

# SUD Reform Update: Effective Dates

Lucas Peterson | Behavioral Health Division

### **Effective Dates for Providing Services**

Services include: Comprehensive Assessment, Recovery Peer Services, SUD Treatment Coordination

- <u>Fee for Service</u>: Effective January 1, 2019 new services listed above are able to be provided. The first eligible billing period for fee for service clients would be 1/8/2019. Please note that in order to bill for these services they will need to be authorized on a service agreement.
- Managed Care: Effective January 1, 2019 new services listed above are able to be provided. Billing can be submitted beginning January 1, 2019.
   MUST have a current contract with MCO that includes the new services prior to billing.

### MCO Contracting

Minnesota Health Care Programs (MHCP) Substance Use Disorder (SUD)-non-residential enrolled providers

Please begin reaching out to MCOs to credential, contract, or amend contracts to include (Comprehensive Assessment, Substance Use Treatment Coordination, and Peer Recovery Support Services).

If you do not have contracts and credentialing completed with MCOs for Medical Assistance (MA) and MinnesotaCare members, there is a risk that you may not receive reimbursement for services. MCOs are responsible for establishing their own provider networks and are not required to contract with all SUD providers.

# Individual: Substance Use Disorder Professional (Not currently enrolled)

- DHS 4016 MHCP Individual Practitioner Provider Enrollment Application Status: Enrollment form has not yet been updated to reflect new provider types
  - Provider will need to write in the provider type on the application if it isn't already listed. Provider Type for LADCs and UMICAD level III= "DC". See screenshot in upcoming slide for an example.

# Existing Professional Providers who want to provide substance use disorder treatment services (Currently enrolled with MHCP) continued...

- <u>DHS 7754</u> Substance Use Disorder (SUD) Provider Assurance Statement-Professionals Status: Document not yet available on edocs, will need to contact the provider call center for PDF document.
- Proof of general liability insurance in the amount of \$2 million for each occurrence
- Fee not required

# Counties and Tribes: Type 45 & 51 (Currently enrolled with MHCP)

- <u>DHS 7820</u> Substance Use Disorder Provider Assurance Statement- Counties and Tribes. Status: Document not yet available on edocs, will need to contact the provider call center for PDF document.
- DHS 3491 Consolidated Chemical Dependency Treatment Fund (CCDTF)
   Provider Assurance Statement Status: Document not yet available on edocs, will need to contact the provider call center for PDF document.
- If newly enrolled, <u>DHS 4016A</u>, <u>DHS 5259</u>, <u>DHS 4138</u> are required. May need <u>DHS 6382 or 6381</u>.

# Recovery Community Organizations (RCOs)

- We are still working on the details for Recovery Community Organizations and enrollment. We will continue to communicate on the status and reach out to RCOs through our communication channels when more details arise.

# Licensed Non-residential Substance Use Disorder Treatment Providers (Currently enrolled with MHCP)

- Licensed non-residential SUD treatment providers will have specialty codes of treatment coordination, peer recovery support services, and the comprehensive assessment added to their Minnesota Health Care Programs (MHCP) MMIS file to allow for billing of these services from 1/1/2019.
- The first eligible billing period for fee for service clients would be 1/8/2019.
   \*Programs will receive information regarding this change to their provider file via the MN-Its mailbox.
- MHCP completes a revalidation process with programs periodically and programs will be required to submit forms to validate these services at that time.

# Licensed Residential SUD Treatment Providers and Opioid Treatment Programs (currently enrolled)

- Nothing is changing for these providers at this time
- Once we get closer to the direct access process being utilized, we will provide you with the next steps moving forward

# New Licensed SUD Treatment Program (Not currently enrolled)

- DHS-4016A MHCP Organization Provider Enrollment Application
- DHS-4138 Minnesota Department of Human Services Provider Agreement

# New SUD Treatment Program (Not currently enrolled) continued...

- DHS-5259 Disclosure of Ownership and Control Interest of an Entity
- <u>DHS 6381</u> CCDTF Residential/Inpatient Assurance Statement (if applicable).
- DHS 6382 CCDTF Outpatient Services Assurance Statement (if applicable)
- <u>DHS 3491</u> Provider Agreement Addendum- Consolidated Chemical Dependency Treatment Fund (CCDTF) Status: Document not yet available on edocs, will need to contact the provider call center for PDF document.
- Fee required (Current 2018-\$569.00) or proof fee was paid to another state or Medicare.

# New SUD Treatment Program (Not currently enrolled) continued...

- Provide proof of employee dishonesty bond in the amount of \$10,000 if the provider has custody or control of money or property belonging to a client (required for residential providers, required for non-residential providers who will have custody of money or property belonging to a client)
- Proof of general liability insurance in the amount of \$2 million for each occurrence.
- Copy of current license(s)



# **Enrollment Process and Approvals**

### **Enrollment Process and Approvals**

- Call Provider Call Center for appropriate forms and documentation needed to enroll
- Complete forms and compile validation of documenting needs
- Fax all forms to MHCP Provider Enrollment at 651-431-7462.
- Forms are processed in date order received. Allow 30 days for processing. If
  more information is needed to complete your enrollment, PE will send a notice
  or letter telling you what is needed to complete your enrollment.



### **Reporting Changes**

- Report any changes made on a provider record to MHCP Provider Enrollment.
- Refer to the <u>Change of Enrollment</u> Information in the <u>Provider</u>
   Requirements section of the MHCP Provider Manual for details.

### **Updated Enrollment Forms**

#### Which forms are currently available and how do I access them?

• See previous PowerPoint slides. You will be notified when forms are accessible and the way you will be able to access them. For available PDF forms you will call the provider call center.

#### How do I fill out the current forms (pdf ones)?

 Providers will need to print out the document and write in the information prior to faxing to Provider Enrollment

#### How will this change once forms are finalized and on PE website?

Once the forms are finalized, they will all be available as edocs

#### Moving Forward: What are effective dates? 1-1-19

• An effective date is the date that you or your organization attests to meeting the qualifications to provide the services according to statute. This cannot be before 1/1/19 for new SUD services (Comprehensive assessment, peer recovery support services, or treatment coordination).

#### When can someone start enrolling?

Once the forms are all available you can submit them via fax to provider enrollment.
